



# Humble Beginnings

It all began with a core-shattering incident that took place years ago, an incident that compelled the organization's founder Srila Prabhupada to take some sort of corrective action.

When in Mayapur in West Bengal, a vision outside his window had Srila Prabhupada in immense distress. He witnessed a group of young childre fighting for rotting scraps of food with a group of street dogs. The scene was so gruesome and heart wrenching that it had him determined to prevent it from happening ever again.

This was the birth of the ISKCON Food Relief Foundation; the concept was based on the vision that no child should go hungry.

Srila Prabhupada did not just preach the doctrines he believed in, but he actually implemented them in reality. The food that is now provided to so many children across India started with humble beginning where Srila Prabhupada himself did not hesitate to cook when needed. By cooking lovingly for the twenty odd people who turned up at the centers, Srila Prabhupada set the right example for years to come; an example that hinted at service, dedication to a cause and nobility of virtue. An example that we still imbibe at Annamrita, even when the number in twenties has now converted to millions.


Annamrita still stands on the same principles, feeding needy children with nutritious and hearty meals that will make them keep coming back, not because they are from a particular sect or stand for a particular belief but because the food is simply too delicious and nutritious to miss out on. Providing nutritious and tasty meals for underprivileged children in aided and non-aided schools has always been, still is, and shall always remain the Annamrita story and way of life!

### The Concept Expanded

The founding hopes for the institution are multidimensional, though they appear to be as simple as 'providing food to the needy'. Annamrita's meals-for-the-needy have the secondary objective of increasing school turnout. While the idea 6 years ago was based on the simple premise of touching the lives of students in Government schools, it has definitely moved far beyond that now.

While India has definitely progressed in leaps and bounds in the last few decades, there is a definite disparity between the rich and the poor, even now. There are still thousands of people out there who struggle to have even one square meal per day, as they find themselves in the vicious circle of poverty and illiteracy. While Annamrita definitely cannot do it all, it can certainly help take the food struggle out of the equation for these needy children, by making good, wholesome and nutritious food available to them.

Annamrita, just as the name suggests, provides the 'amrita' (ambrosia) in the form of 'anna' (food) to children of several underprivileged sections of society irrespective of their backgrounds, caste and religion. It is nothing short of food as pure as nectar which truly satiates. Annamrita's technologically equipped kitchens are feeding over **9.07 Lakhs children** across seven diverse states in India with nutritious, healthy and tasty food that satiates both the body and the soul.

# Growing Together

The success of our journey towards growth has been due to the concerted efforts of our parent initiator and the ISKCON Food Relief Foundation. The latter is a non-profit, non-religious and nonsectarian public charitable trust that was formed on the 15th of July 2004 with a registration under the Bombay Public Trusts Act 1950.

The successful 'Midday Meal' program in schools was conceived by the Government of India, to attract children to school and to get them educated by sharing the financial responsibility of the parents and thereby encouraging them to send their children for proper education to local schools.

This program has reaped particular benefits in the sector of 'girl child education' in the country. Moreover, by serving a common meal to all and that too on a common platform, the program has been instrumental in helping children unite and rise above cultural and caste differences.

Our statistics prove a year-by-year account of the growing coverage of Annamrita's midday meal program and thereby highlight its contribution in upholding the right to education for every child in India, an effort that we are humbly proud of and are inspired to take further ahead.





With a small beginning of just about 20,719 children in year 2004-05, the figure of 6,60,000 children in 2009-10 was truly an achievement beyond anyone's imagination. That figure of 6,60,000 children has now reached to 9,07,171 in the year 2011-12 and still counting...

Though these figures are simply numbers, one can only estimate the extraordinary impact they have had on the nutrition, literacy and turnout statistics of the country. A direct impact of this mid-day meal program has been in providing children with good nutrition, something that is absolutely imperative for proper cognitive development in children, especially between 6-12 years of age. India's potential development has been largely curbed due to hunger and malnutrition, things that we wish to help eradicate.

Seeing the impact that this program has had on breaking the vicious poverty-illiteracy cycle in India, it is our strong resolve to pledge more resources into the cause in the years to come and liberate millions of more underprivileged children in the country by helping them build a future that is brimming with dignity and a sense of fulfillment.

The Ministry of Home Affairs of the Government of India has also accorded us the permission to collect overseas donations under the Foreign Contribution Regulation Act (FCRA), 1976, thus further increasing our fundraising avenues. We have equally reciprocated their trust in us by furnishing the requisite returns on time, year after year, and we stay committed to such respect and accountability in the years to come, to make this journey a story of national success.



# Inside the KitChens

### Where Millions Who Seek a Meal Find a Mother

Annamrita, as the name suggests, is an organization that works on the premise of providing wholesome food for under-privileged and under-nourished children. So, food preparation indeed forms a part of its core activity. So, here's how the food preparation procedures take place at all Annamrita kitchens across India. It is during the most pious period of Bramha muhurta (3:00 a.m.) that the Annamrita kitchens begin their daily operations to prepare meals for hundreds and thousands of underprivileged children across India.

Dressed in clean uniforms, aprons, caps, gloves and safety footwear, every Annamrita kitchen employee adheres to the highest standards of cleanliness and hygiene. It is this that has helped us achieve our coveted ISO certification.

All raw materials such as rice and pulses are stored only after a thorough inspection. Even the vegetables used in our meals are freshly bought and meticulously







cleaned. The storage and sourcing procedures at Annamrita are ritualistically followed. Before it is time to actually start making the food, the preparation procedures such as chopping vegetables in machines, washing the rice and pulses, etc. begin. The cooking process starts only after all the preparations are complete. Rice, lentils and grams (as per the day's menu) are steamed in giant cauldrons using steam generated from a boiler. The 'chaunce' is prepared separately using cooking oil and spices and it is later mixed with the rice and vegetables or dal, once everything has been cooked to perfection. Water used in the preparation of our meals is first filtered, softened and inspected for hardness below 5 ppm and also periodically analyzed for pathogen content to confirm to IS 10500. The food prepared is tasted for salt/spices and any unintentional contamination, before it is ready to be packed for delivery at 8:00 a.m.

After the approval of the quality control supervisors, the food is packed in 10 kg containers and sealed, which are then loaded in our dedicated distribution vans. Each of our vans reach the schools just before lunch break and they do so ritualistically and unfailingly. Every delivery is then once again inspected by the school authorities.

They check our seals before distributing the food amongst the wards. This stringent measure ensures that the food remains untouched and unexposed to outer elements from the time it has been packed, to the time it has been served to the students.

Back in the kitchen, all kitchen equipments are carefully cleaned after the morning's meal dispatch, to bring the process to one full circle. At Annamrita, every care is taken, not just in the preparation of food but also when it comes to the environment and the people who make it.

Additionally, every kitchen at Annamrita has been designed to provide healthy ventilation, sufficient lighting, fire safety equipment & First Aid toolkits. To maintain high levels of quality control, all cooking staff is also required to undergo regular government approved medical checkups.

It is with such immaculate measures that Annamrita practices its founding doctrines of care, purity and devotion in the preparation of its every meal. This is also a hallmark of our integrity and the emotion behind our service towards the children of our country, an emotion that can well substitute a mother's love.





# What's For Lunch?

### **Annamrita Meal Times**

As we all know, the core product of Annamrita happens to be the midday meals that are served at schools to underprivileged children. This is done to increase the attendance compliance and increase the literacy rates in certain segments of the population.

So, what exactly do we serve these little children? Is it our food nutritious? Is it made under hygienic conditions? Here's the breakdown of the answers to all these questions and more.

### An Appetizing Menu

Though the menu of food items that we give the children differs both according to region as well as regional taste palates, one thing that we never change is our commitment to quality and nutrition. We also vary our food menus according to the different days of the week so that the students never get bored of one particular food item. Some of the items on our menu are:

**Usal Rice:** Usal rice or lentil rice is nothing but well-cooked rice with Usal or lentil gravy. This food item is well received in several regions of Maharashtra, as it is as good as staple food in many households here.





**Chapati Bhaji:** Though this item is served only in schools in northern India, it is very homely and well loved. Students clamber to our vans when it is the 'chapati bhaji' day.



**Puri Bhaji:** This is a slight variation of the 'chapati bhaji' option where the pan-roasted chapatis are substituted with deep fried puris. This tasty optionis only available in select schools in North India.





**Pulav:** Now who doesn't love Pulav? And our kids certainly do! Pulav is made of rice and chopped vegetables and spices. It is not only tasty but it is also

nutritious.

**Bhel:** Bhel is the best loved street food in India but we make it up into a healthy and nutritious meal for our children. Not only do the children love it but they even



sneak some home to their families that love it too!



**Sambar Rice:** Well-seasoned sambar (a type of South Indian dal) along with well-cooked rice is served to children on several days. The sambar is spicy and

tangy, tastes that go down really well with little kids.

**Amti Rice:** A traditional rice and dal combo that is famous in Maharashtra, is called as 'amti rice' in this region. Children are well familiar with this meal and hence



have no qualms about gulping it right down.



Usal Khichdi: This is a standard rice style known as Usal Khichdi and Usal Khichdi is simply a khichdi with some lentils and pulses added in for taste. This

well-spiced rice dish is very famous in some

circles.

Sweet Rice: Considered as a delicacy in some parts of India, this rice is served as a sweetener that adds more glamour to the normal or routine Annamrita menus.





**Sprouted Lentils Khichdi:** Extremely nutritious and full of protein, this rice dish is a real winner. Consisting of spiced and flavored rice with boiled sprouts,

this khichdi is also a hit in most cities across India.

**Mung Dal Khichdi:** This is the basic and most well-known khichdi that most kitchens in India are familiar with it. They say that the simplest of things are often the



tastiest and at Annamrita, we prove it with our mung dal khichdi.



Halva: In some public schools across India, little children sometimes get a treat indeed! Annamrita's rava halva is not just a delicious treat cum dessert but it is

also nutritious and heart-warming. Loaded with goodies such as dry fruits, our halva is unanimously loved, irrespective of the state, place or palate that it is served to.

Annamrita takes all possible care to serve the best quality food that is high in nutrition value as well as in taste, to the school children that it caters to.


### Wherever a Child Needs, A Mother is Always There

# Activity Highlights

### A Glimpse into Our 2012 Diary

The 12 months of the operating year 2011-12 have just rolled by and as we look back and reassess, the year's achievements leave us proud and reeling. Here are some of the most talked about highlights of our year at Annamrita.



### School=Lunch is Now Rebranded as Annamrita

The Government of India's Midday Meal Scheme was not just piggybacked by the ISKCON Food Relief Foundation but was actually rebranded with the selfexplanatory term 'Annamrita'. The new brand was unveiled at the gala 'INSPIRO YOUTH FIESTA' in Mumbai before about 25,000 people in January, as the New Year began with new festivities for us. The brand was inaugurated at the hands of the gorgeous and talented Sonam Kapoor, who later went on to exclaim in surprise that the 'khichdi' she tasted was just so yummy!

### Annamrita Included in the National CSR Hub

With Corporate Social Responsibility (CSR) f i g u r i n g q u i t e significantly in the new Companies Bill being d e b a t e d i n t h e parliament, India Inc. may figure much more prominently amongst



our supporters in the years to come. The Ministry of Company Affairs (MCA) has accepted a recommendation for companies to set aside a certain portion of their profits, each year, towards social causes. The proposal is that companies with over Rs. 1000 crores in turnover or about Rs. 5 crores in profits, should have about 2 percent of the latter earmarked for CSR for the next 3 years. To make this CSR earmarking an effortless process, Tata Institute of Social Sciences (TISS) has come up with a panel of certified NGOs. The good news for us is that we have been selected on this panel and very soon we can look forward to reaping its elite benefits.

### Launching of Midday Meal in Chembur-Joint Project of Annamrita & RCF



In association with Rashtriya Chemicals and Fertilizers Ltd. (RCF), Annamrita has started its midday meals program in Chembur as well. About 4100 students from non-aided schools are expected to benefit from this campaign. The launch of this Annamrita chapter in Decembar saw several eminent dignitaries come together to express their support.

### Annamrita's New Kitchen in Aurangabad



In association with the Aurangabad Municipal Corporation (AMC), Annamrita set its eyes on this region in February 2012. By setting up a new unit here, Annamrita started its 'meals for children' campaign in full swing here as well. Currently this Annamrita kitchen caters to the nutritional needs of about 20,000 school-going children from 78 schools. Even then, this kitchen has not reached its capacity and has the capability of feeding about 1 lakh children every single day. Several eminent guests of honor and some primary school children got a sample of our famous 'khichdi' on the inauguration day. Annamrita - Spreading the Waves of Hope and Inspiration In the Steel City



Annamrita, in association with Govt. of Jharkhand and Tata Steel, rolled out its new Midday Meal Program in Jharkhand on 8th April, 2012. This will provide the right nutrition to underprivileged children to support their education, in the state of Jharkhand.

The Chief Minister, Sri Arjun Munda, inaugurating the program at Ramdas Bhatta Community Centre at Jharkhand, said that he was highly impressed with the work of Annamrita during his last visit to its Delhi Centre. Ever since, he firmed up his intent to invite Annamrita to Jharkhand State. He took this forward by speaking to Mr. H. M. Nerurkar-- M.D., Tata Steel who expressed a keen interest. Thus the foundation stone was laid in July 2011.

The pilot project, first of its kind in the State, is having the capacity to provide hygienic and nutritious food to over 1 Lakh students in and around Jamshedpur and adjoining Seraikela-Kharswan districts. Around 389 schools of Jharkhand will be covered under this scheme which will benefit approximately 65,000 children initially.

The infrastructure and the land for running the program, has been provided by Tata Steel. We express our heartiest thanks to the Govt. of Jharkhand and Tata Steel for this initiative.

### Creativity From Nourished Annamrita Children

With Annamrita's entry in the schools of Chembur came several fruitful revelations, namely, that our children sure have talent! Chembur's hearingimpaired children



from Rochiram Thadani High School had highlighted their skill for us. These students had been collecting the waste seals that had been used to lock the midday meal containers and coming up with beautifully crafted table pots, later framed in glass boxes. We now know what good nutrition can do for these talented and intelligent kids and this spurts us on to maintain the nutrition component of our meals and make everything achievable for these young minds. donation vehicle also runs in the Nashik Industrial cluster of Ambad. The drive, which was a result of Annamrita's association with Janakalyan Blood Bank and Dilip Coach Company, received phenomenal participation. While the blood was handed over to Janakalyan Blood Bank, our 25 volunteers worked hard at running the whole process smoothly. Though 'midday meals for underprivileged children' happens to be our main agenda, Annamrita has not stopped its social work there. Very recently, Annamrita launched a blood donation camp in Nashik. A blood Malad's Malvani slums are the second largest slums in Asia after the infamous Dharavi. Though the per capita income of residents in these slums are much lower as compared to Dharavi, the estimated population living in them is over 1.1 million. Annamrita has started its midday meal program in 23 schools in this region, with 23,000 slum children (approximately 60 percent of the slum population) benefiting from the facility. The improvement in attendance rates at these schools is testimony to the change that Annamrita is effectively bringing about.
